## **Statutory consultation on school admission arrangements at Atwood Primary School**

The Directors of the Pegasus Academy Trust are consulting on a proposed change to the admission criteria (how school places are allocated) at Atwood Primary School, Limpsfield Road, Sanderstead, South Croydon, CR2 9EE. These changes are proposed to take effect from September 2026. You are being contacted because you may have an interest in this matter. Atwood Primary School joined the Pegasus Academy Trust on 1<sup>st</sup> September 2022 and is now an established member of the Trust. The consultation details are as follows:

**Consultation period:** Tuesday 1<sup>st</sup> October 2024 to Friday 29<sup>th</sup> November 2024 – 9 weeks in total.

**Proposed change:** The Directors of the Trust propose that Atwood Primary School would adopt the admission criteria used by the other schools in the Trust. The existing Atwood admissions policy and the Pegasus policy are already very similar. The most notable change is that a staff criteria for admissions would be introduced as explained at section [3.8] of the policy and in note 4 at [4.4]. **Why is this change being proposed?** The Directors of the Pegasus Academy Trust are undertaking this change to align the admission criteria of the school with those currently used at the other five schools in the Trust.
